Re: Co-Sponsor the Affordable Connectivity Program Extension Act of 2024

Dear Members of the House of Representatives,

The undersigned organizations, which represent a diverse coalition of our nation's population and interests, write to strongly urge you to continue the work you have done to make high-speed home broadband internet service affordable and accessible across the country by co-sponsoring the bipartisan *Affordable Connectivity Program Extension Act of 2024*, which provides \$7 billion in funding to continue the Affordable Connectivity Program (ACP). To date, the ACP has successfully allowed over 22 million households¹ in equal numbers of Republican and Democratic districts to experience the transformative power of high-speed home broadband service in the lives of families and children by expanding access to education, job opportunities, telehealth, e-commerce, entrepreneurship, civic participation, communication with loved ones and more. Although \$7 billion will only fund the ACP through, at longest, the end of 2024, it is a critical step toward continuing the significant bipartisan success of this program to provide connectivity nationwide.²

Based on projected growth, funding for the ACP could be depleted within the next three to four months, if not sooner.³ Without additional funding for the ACP, millions of families who rely on the program would see their home internet bill increase beyond their means to afford it, which could result in having their service disconnected. The nation cannot afford the risk of losing the success of the ACP's ability to help close the opportunity gap for the millions of families who have come to rely on high-speed home internet access for education, telehealth, employment, and more.

The COVID-19 pandemic demonstrated that access to high-speed home broadband internet service is not a luxury, it is a necessity. Congress recognized in its original funding for the ACP

that access to affordable high-speed home broadband service is a necessity in the 21st century, particularly for low-income people, communities of color, and other marginalized and underserved communities. High-speed home broadband service provides people with the ability to participate and compete in the digital economy, access employment, online education, remote work, entrepreneurship opportunities, participate in civil engagement, and utilize telehealth services. Affordable high-speed home broadband internet service also advances economic empowerment and narrows the digital skills gap that currently impacts our nation's marginalized populations.⁵

The Infrastructure Investment and Jobs Act provided the original funding for the ACP.⁶ This bipartisan legislation also provided a historic investment of \$42.45 billion in the Broadband Equity and Deployment⁷ (BEAD) program to expand access to high-speed home internet by funding infrastructure deployment throughout the nation. The BEAD and ACP programs work in tandem to achieve Congress' goal of universal broadband deployment and adoption throughout our nation. Failure to provide continued funding for the ACP would reduce the efficacy of Congress' investment in the BEAD broadband deployment program and thwart its goal of universal broadband deployment and adoption for our nation.

Thank you for the work you have done to make high-speed home broadband service affordable to households across the country. We look forward to your leadership in support of the *Affordable Connectivity Program Extension Act of 2024* to maintain the progress that the ACP has made to close the nation's digital gap and secure a digitally connected future for all.
